



Privacy Policy

At Ranger4 we believe strongly in protecting our users' privacy. We will not willfully disclose information about our users to any third party without first receiving our users' consent.

Your personal information

All personal information you provide via our website will be treated as private and confidential.

We may use this data to contact you when you have submitted a form on our website and to send you marketing communications. The GDPR lawful basis for collecting and using this data is Consent. Ranger4 use an automated marketing platform to ensure that the information we send you is relevant. This is based on criteria such as job title, industry, type of content downloaded and website pages visited.

After two years of inactivity with Ranger4 your details will be permanently deleted from our records. Inactivity is defined as no contact with Ranger4 through website visits and downloading of information.

You have the right to withdraw consent for Ranger4 to use your personal information at any time.

You have the right to lodge a complaint to the Information Commissioner's Office if you believe your information is not being processed in accordance with the GDPR.
